Presently, around 5843 nos. women SHGs,291 nos. ALFs and 05nos. CLFsare formed across the State. As on date, 2025 more than 56,660 urban poor women have been mobilized into women SHGs. For livelihood activities, a network of Community Resource Persons are involved as Bank Sakhi, Jal Sakhi, Digipay Sakhi etc. So far, Rs. 96 Cr. bank loan have been provided to urban women SHGs across the State. With the effort and dedication of the TULM, now women SHGs become very important clients to banks.

It's a pleasure to note that because of efforts made by TULM, UD Department, many women are linked with sustainable livelihoods for enhancing their income.

Tripura Urban Livelihoods Mission is one of the largest community development programs of the state, directly dealing with around 56,660 urban poor women who have been mobilized into Self Help Groups (SHGs), Area Level Federations (ALFs) and City Level Federations (CLFs). It is a highly process oriented program where the capacity building of these women led community institutions is being done in a way to ensure that these institutions ultimately become women led and self-managed institutions. The City Level Federations (CLFs) are robust community institutions, created and strengthened over a period of time, for the sustainable and robust implementation of various TULM interventions. To anchor the entire process, CLFs are strengthened with the required skills and expertise.

Social capital in the form of Community Resource Persons (CRPs) has been developed for day-to-day management of these institutions. The mission has nurtured a large number of Community Resource Persons (CRPs), who are TULM's feet on the ground and are instrumental in facilitating the interventions taken up by the State mission. At present more than 210 nos. CRPs & 56 nos. of Bank Sakhis/Digipay Sakhis are deployed by the mission. These CRPs are well trained on technical aspects of livelihood interventions and related extension services.

A significant headway has been made in financial inclusion w.r.t financial literacy, opening of Bank accounts, credit linkage, insurance coverage etc. For augmenting livelihood, the credit support to women SHG members are available @7% interest rates from banks.

It is also pertinent to mention that Pradhan Mantri Street Vendor's Atma Nirbhar Nidhi (PM SVANidhi) is a special Micro-Credit facility launched by Ministry of Housing & Urban Affairs, for providing affordable loans to street vendor.

ripura Urban Livelihoods Mission was established with an objective to reduce poverty and vulnerability of the urban poor households by enabling them to access gainful self-employment and skilled wage employment opportunities, resulting in an appreciable improvement in their livelihoods on a sustainable basis, through building strong grassroots level institutions of the poor. The mission would aim at providing shelters equipped with essential services to the urban homeless in a phased manner. In addition, the mission would also address livelihood concerns of the urban street vendors by facilitating access to suitable spaces, institutional credit, social security and skills to the urban street vendors for accessing emerging market opportunities. The Mission pursue to address the multifaceted challenges faced by urban poor households, particularly within the informal sector, by adopting an inclusive approach that includes urban poor households, especially women, the elderly, the differently abled, migrants, and marginalised communities. The Mission brings focus to vulnerable occupational groups, who are often marginalised within

the broader labour market. This includes workers in sectors such as care, domestic, transportation, construction, gig, and waste workers, who face disproportionate challenges and barriers. The Mission encompasses a comprehensive strategy for addressing these challenges by providing financial assistance for microenterprises and promoting access to credit. The Mission is aligned to the Sustainable Development Goals (SDGs) and aims to alleviate urban poverty and foster economic independence. Special attention is given to women through support for selfemployment and participation in Self-Help Groups (SHGs) or Common Interest Groups (CIGs), thereby advancing gender equality and enhancing their economic and social empowerment. Additionally, the Mission also focuses on creating sustainable livelihoods and decent work opportunities while striving to reduce inequalities and promote social inclusion among marginalised urban populations. This holistic approach contributes to the development of sustainable cities and communities, ensuring that urban growth translates into improved quality of life and resilience for all residents.

With improved earnings, he now manages household expenses, provides quality education for his children, and enjoys a higher social standing.

These women transitioned from being housewives to successful entrepreneurs in bamboo product manufacturing, supported by the Tripura Urban Livelihoods Mission (TULM).

Starting with a ₹10,000 Revolving Fund and successive bank loans totaling ₹9,00,000, the group expanded their product range to include baskets, mats, and other bamboo items. They

initially sold their products locally but now also market them on major e-commerce platforms

like Amazon and Flipkart. This expansion increased each member's income to approximately ₹15,300 monthly, enhancing their financial independence and social recognition.

Future plans include setting up a factory to streamline production and further scaling their online presence. Dindayal Upadaya SHG's journey exemplifies the transformative power of collective effort, financial assistance, and entrepreneurial spirit, serving as an inspiring model of women's empowerment.

Their initiatives include home delivery and plans to develop an Android app, showcasing their adaptability and ambition. They intent to setup a factory in future which reflects their commitment to scaling operations and creating local job opportunities.



# **Empowering Amarpur: The Journey of Sonali SHG**



he Sonali Self-Help Group (SHG) from Amarpur, Tripura, established on August 15, 2018, is a shining example of womenled empowerment. Starting as a small group of 10 women with a shared hobby, they have transformed into a thriving entrepreneurial venture under the leadership of Shipra Debnath and Radha Rani Das. Operating under the Tripura Urban Livelihoods Mission, the group has become a symbol of self-reliance and determination.

Initially, the group's monthly income ranged between Rs. 6,000 and Rs. 10,000, with an increase during festival seasons. Their journey began with inter-lending among members and evolved into a business after conducting a market study that highlighted the demand for pickles. Using their first loan of Rs. 1 lakh, they purchased essential equipment like grinder machines. This investment enabled them to enhance productivity and gradually increase their earnings.

In May 2023, Sonali SHG secured a second loan of Rs. 3 lakh to further scaleup their operations. Today, they specialize in producing a variety of pickles, including mango, mixed, plum, and tamarind pickles, while also accepting custom orders based on customer demand. Their products are sold locally and in nearby district markets, broadening their customer base and ensuring steady growth.

The journey of Sonali SHG highlights the transformative power of teamwork, dedication, and external support. By creating sustainable livelihoods and uplifting their families, the group serves as an inspiring example of women's empowerment and economic independence. Their story is a testament to the potential of self-help groups in driving community development.

# From Housewives to Entrepreneurs: The Inspiring Story of Swaralipi SHG

waralipi Self-Help Group (SHG) stands as a shining example of how determination and support can transform lives. Formed on December 26, 2014, in Bhowliabasti, Ambassa, under the Tripura Urban Livelihoods Mission (TULM), this group of ten housewives turned their challenges into opportunities by building a successful bakery business. Initially struggling to make ends meet, these women found financial independence and empowerment through Swaralipi SHG.

With initial assistance from TULM, the group received a Revolving Fund of ₹10,000, which served as the foundation for their entrepreneurial journey. In 2021, they secured a loan of ₹1 lakh to establish a bakery production unit. After successfully repaying this loan, the group expanded their operations with a second loan of ₹3 lakh in 2023. Additionally, two members of the group received ₹80,000 under the PMFME scheme, further enhancing their production capabilities.

To ensure their success, Swaralipi SHG members underwent training in leadership, entrepreneurship development, and marketing. These initiatives equipped them with the necessary skills to run their business effectively. With the establishment of a permanent bakery production unit and the support of the Community Livelihood Center, the group significantly improved their production processes and expanded their market reach.



Today, Swaralipi SHG not only provides a stable source of income for their families but also serves as an inspiration to other women in their community. By breaking traditional barriers and embracing opportunities, they have become role models, demonstrating that financial support, training, and teamwork can lead to transformative success. The journey of Swaralipi SHG is a testament to the power of resilience, unity, and vision in creating sustainable livelihoods.

# Jaggery Vendor Triumphs: Shri Prabin Chandra Deb's Success Story



hri Prabin Chandra Deb, a street vendor from Ambassa Colony, Tripura, has transformed his life with determination and support under the PM SVANidhi scheme. Selling jaggery near Pally Mangal Club, he overcame financial struggles to build a sustainable livelihood.

Before financial aid, his income of Rs. 4,000–6,000 per month was insufficient to meet his family's needs. Through PM

SVANidhi, he secured three loans—Rs. 10,000 in 2020, Rs. 20,000 in 2022, and Rs. 50,000 in 2024—enabling him to expand his business. His income now ranges from Rs. 15,000 to Rs. 20,000 monthly.

The project's impact is multifaceted, creating steady incomes, promoting hygiene, and fostering sustainability. By driving economic and social change, the Atma Nirbhar Mahila ALF stands as a testament to the power of women-led entrepreneurship.
