The committee, comprising representatives from relevant departments, will be responsible for reviewing and screening city-level project proposals in accordance with the guidelines of the Social Infrastructure component under Deendayal-Jaan Aajivika Yojana (S), as issued by the Ministry of Housing and Urban Affairs (MoHUA). The Responsibility of Project Review Committee (PRC) at state level are as follows-

1. The PRC considers and screens all proposals submitted by Urban Local Bodies (ULBs) under the Mission.
2. These proposals may include construction or refurbishment of social infrastructure like shelters, CLCs, Labour Chowk and Care Cluster.
3. After screening, the PRC forwards the proposals to the Ministry of Housing and Urban Affairs (MoHUA) for approval by the competent authority.
4. For approved projects, the PRC determines milestones for the release of allocated funds.
5. The PRC is required to meet at least once a quarter.
