The **Technical Bid** will be opened on **14/11/2025** at **12:30** pm in the presence of bidders. The **Financial Bid** will be opened only after evaluation of the Technical Bid. No further correspondence will be entertained in this regard.

Rate to be quoted for:

- 1. Detention Charge per Day
- 2. Running Charge per Km

Formats of Technical Bid (Annexure-I) and Financial Bid (Annexure-II) are enclosed.

Terms & Conditions:

- 1. An Earnest Money Deposit (EMD) of ₹10,000/- (Rupees Ten Thousand) only, in the form of a Deposit at Call or Demand Draft drawn in favour of "Tripura Urban Livelihoods Mission" payable at Agartala from any Nationalized Bank/Tripura Gramin Bank/Tripura State Cooperative Bank, must be submitted with the sealed quotation.
 - For the successful bidder, the EMD will be converted into a Security Deposit.
 - For others, it will be refunded.
- 2. The bidder must submit valid documents:
 - Commercial Registration (not before 1st January 2025)
 - Aadhaar Card of the Owner
 - Vehicle Insurance
 - Valid Road Permit
- 3. The vehicle should be in good running condition and **not purchased before 01/01/2025**. Copies of valid purchase documents, as per the Motor Vehicle Act, must be attached to the quotation. Only **Maruti ECO/Wagon R (Petrol Variant)** will be accepted.
- **4.** The owner shall bear all costs of fuel, lubricants, maintenance, and dusters for the car. The vehicle must be equipped with a **minimum of basic accessories** at the owner's cost.
- 5. The KM reading meter should be fitted and in proper working condition.
- 6. The vehicle must have a valid commercial license.
- 7. The vehicle must be provided with a driver holding a valid driving license. All expenses of the driver shall be borne by the vehicle owner.
- 8. The successful bidder shall submit copies of the Aadhaar Card and Driving License of the driver to SMMU, TULM.
- 9. In case of breakdown, accident, or defect, the owner shall repair the vehicle at his own cost and risk. An alternative vehicle of similar quality must be provided without delay.
- 10. If the condition of the vehicle or the service of the driver is unsatisfactory, the vehicle will be discontinued
- 11. Payment will be made on a **monthly basis** against the submission of the bill & logbook.
- 12. The rate and work order shall remain valid for **1** (one) year from the date of issue. Extension may be considered with mutual consent, subject to satisfactory performance.
- 13. If the successful bidder fails or refuses to continue service within the contract period after award, 50% of the Security Deposit shall be forfeited as a penalty.
- 14. Applicable taxes will be deducted from the bill as per the rules.
- 15. A Log Book in the prescribed format must be maintained for daily journeys.
- 16. Rates must be quoted in both figures and words.
- 17. Quotations received after the stipulated date and time will not be entertained.
- 18. No additional claim, except detention charges per day and running charges per km, will be entertained
- 19. The detention charges per day, running charges per km and monthly celling Limit must be within the ceiling limit prescribed in DFPRT 2019.

Additional Terms & Conditions:

- 23. The vehicle should report to duty on time every day, delays without a valid reason may invite a penalty.

- 25. The vehicle must have a valid Pollution Under Control (PUC) certificate.
- 26. The driver must have a working mobile phone at their own cost for smooth communication.
- 27. The vehicle must be provided with at least two spare tyres, a toolkit, and a first- aid box.
- 28. The owner shall be responsible for any legal disputes, traffic challans, or penalties arising out of improper documents or negligence of the driver.
- 29. Replacement of the vehicle with a similar specification must be ensured if the existing vehicle is sent for servicing/maintenance.
- 30. The driver must not drive the vehicle under the influence of alcohol or any Intoxicating substance.
- 31. Any damage/loss caused to Government property due to negligence of the driver shall be borne by the vehicle owner.
- 32. The office reserves the right to terminate the contract at any time with **15 days notice** if services are found unsatisfactory.
- 33. Incase of received same quoted rate from different agencies/individual the Evolution committee will decide depending on Experience.

42. Evaluation of Financial Bids:-

As per the tender conditions, the evaluation of bids is carried out by considering both the Daily Detention Charge and the Rate per Km. For comparison, an average daily usage of 80 km has been assumed. The total evaluated cost per day for each bidder is calculated as:

Evaluated Cost per Day=Daily Rent+(Rate per Km×80)

Result of the above illustrative example:
